Treasurer's/Budget Report

Sue reported that Cynthia received an invoice for refreshments, which seemed to be from Speaker Series. Winky stated that the budget for Speakers Series was increased at a previous meeting. The invoice was determined appropriate. Judy relayed Shally's request for another \$50 for books for Reading Rocks for the class at West Side School. The Board approved transfer of \$50 from unbudgeted to Reading Rocks. Sue asked if any Board member wanted to go to the National Convention in San Diego in June.
