The Build Back Better Bill is Good for Women

The BUILD BACK BETTER bill (H.R. 5376) is unequivocally good for women and that's why AAUW supports its passage. Three of the BBB's provisions will provide meaningful support to women and families and are thus critical to AAUW's mission. The three are:

1. Universal paid family and medical leave up to 12 weeks

More than 120 nations, including Botswana and Algeria have some form of paid family leave. This is because, according to the International Labor Office, "in all parts of the world, working women who become pregnant are faced with the threat of job loss, suspended earnings and increased health risks due to inadequate safeguards for their employment." It's shocking that the U.S. falls behind in supporting families.

2. An extension of the child tax credit through 2022

The Child Tax Credit provides couples earning \$150,000 and individuals with children earning \$112,500 a year or less with up to \$3,000 per year in child tax credits. A study conducted by the Center on Budget and Policy Priorities estimates that the new temporary expansion of the child tax credit will cut the poverty rate nearly by 50% and lift 4.1 million children out of poverty this year. In 2020, about 11 million children were living in poverty, according to data from the Organization for Economic Co-operation and Development (OECD).

3. Affordable Child care.

The BBB addresses widespread challenges with access, affordability, and quality in early learning, while reinforcing the benefits of a strong mixed-delivery system that prioritizes parent choice in determining the type and setting of care that best meets a family's needs. The proposal seeks to resolve chronic foundational flaws in America's childcare market caused by decades of underinvestment, which create an entirely unsustainable business model for providers that often translates into near-poverty wages for early educators.

Additionally, the proposal would build on existing state and federal preschool programs by providing funding to cover the federal share of the cost of a voluntary, free universal pre-k (UPK) program for all children, regardless of income or other eligibility requirements, in a variety of settings.

WHAT CAN YOU DO TO HELP BBB'S PASSAGE??

RESPOND to the 2-minute activist and let our Senators know that passage of BBB is vital to YOU! Even though our Senators are on board already, they can use these communications as leverage in the Senate.
