This is my last newsletter article as President. I am thankful to all those who shared their talents and worked so hard alongside me over the past two years. Special thanks goes to the board members who consistently showed up and offered their creative ideas. Special recognition goes to **Tyra Benoit**, outgoing Public Policy Director, and **Kate Van Ness**, outgoing Past President, for their many contributions. The board and I will miss you both.

2023-24 Goals and Achievements

Each year, the board sets goals for the upcoming year. Here are the goals and how we met them.

Board Goals and Achievements

- Improve End-of-year member donations from the current 30% to 75%.
 - End-of-year member donations increased from 30% to 56% of members donating.
- Support a semi-annual action to support DEI.
 - We held a January event focused on Reproductive Choice and showed the film "Fly So Far" about how women in El Salvador are being prosecuted and imprisoned for miscarriages. The film was followed by a panel of local doctors and a representative from Planned Parenthood discussing the state of reproductive health globally, nationally, and in Sonoma County. Additional participation and collaboration with Indivisible Healdsburg and Sister District was part of the event.
 - We showed the same film to a Spanish-speaking audience on May 17 at the Community Center.
- Continue to develop a long-term fundraising plan.
 - Several ideas were researched. None looked promising for long-term fundraising. Our traditional Homes Tour is being looked at again. In the past, the Homes Tour has raised between \$35,000 and \$60,000 annually.
- Develop a plan for the Speakers Series by December 31 and implement it by early 2024.
 - The Speakers Series commenced in January, with monthly speakers. Our last speaker was Eddy Cummins, the General Manager of SMART, (the SMART train), on May 13.
- Pursue possible development of new interest groups such as Art, Garden, Mahjong, and Movie.
 - A new Travel Group has been formed.

Shining a Light on Clean Energy: TTAG's Impact at Climate Fest

The Tech Trek Alumnae Group (TTAG) illuminated a pathway toward a cleaner, more sustainable future by spotlighting Piezoelectricity. Inspired by its potential, the TTAG board took on the creative challenge of demonstrating the concept and benefits of this innovative technology in their 2024 Climate Fest booth. By integrating piezoelectric sensors that generate electricity into their exhibits, Joie Kozubal, TTAG Co-President, and Rebecca Palubicki, TTAG Membership Coordinator, showcased a flashlight, a 12-key piano, and a jukebox, offering tangible demonstrations of this technology. Valeria Rosas, TTAG Secretary, took charge of designing posters and signs that not only explained the intricacies of piezoelectricity but also offered fascinating fun facts about the technology.

The collaborative efforts of all the dedicated TTAG members who built and operated the booth ensured that the piezoelectric concept resonated with Climate Fest attendees. One visitor was so impressed that he generously donated \$20 for future TTAG STEM activities. Another likened their presentation to a mini TED talk, praising the depth of understanding and passion exhibited by the TTAG team.

Cultural Event- Recology Tour May 15



AAUW members enjoyed an enlightening one-hour tour of the new Recology Recycling Plant in Santa Rosa. Since heavy equipment was involved, we wore vests, hard hats, and microphones in our ears to hear Anita - our guide who explained the whole process.

The Recycling Plant is very impressive, quite complicated, and a bit overwhelming. There are four steps: 1) employees hand sort the items, 2) the plant mechanically sorts the recyclables, 3) another hand sort is completed, 4) a final mechanical sort ends the process.

Educating the public about what is allowed and how not to contaminate their recyclables is an important challenge. While we were there, they pulled a bent-up bicycle and garden hoses off the conveyor belt. California is leading the way in recycling. And, the good news is that many of the articles we read about the issues with plastics do not pertain to California, especially in areas like Sonoma-Marin where they have the equipment to recycle thoroughly, A couple of quick takeaways:

*Blue cans can become contaminated with animal poop or other non-recyclable garbage. Biggest no-no – animal poop and single-use thin plastics. All ridged plastic is OK regardless of the number in the triangle.

*All recyclable items should be clean and dry. If dirty, they go to the landfill.

The mission of AAUW is to promote equity for all women and girls, lifelong education and positive societal change. There is no better way to do this than to award scholarship funds to incredible young women from Windsor, Geyserville, Cloverdale, and Healdsburg High Schools.

This year we were able to award a total of 20 scholarships that ranged from \$2,000 to \$4,000 per student. The criteria that our committee uses consists of grades, financial need, the quality of their essay, community service, and letters of recommendation. It was difficult to choose as all 43 applicants were deserving, but the 20 we chose stood out. We partner with the JNR foundation, a philanthropic women's organization who are particularly interested in awarding scholarships to first generation high school seniors who meet the same criteria. The JNR funds of \$4,000 each were awarded to eight amazing young women and the AAUW scholarships of \$2,000 were awarded to 12 outstanding young women.

I would like to thank the extremely hardworking and dedicated members of the scholarship committee, Julie Hanamura, Debbie Potmesil, and Yvonne Schell who spent many hours reviewing the applications and meeting to choose the applicants. I am also grateful to you, the members of our AAUW branch whose contributions made these scholarships possible. NEW TITLE IX RULES

Biden Admin. Releases Long-Awaited Guidance

HOT OFF THE PRESSES! On Friday, April 19, 2024, the Biden Administration released long-awaited <u>guidance on the</u> <u>application and administration of Title IX</u>. The rule changes (1) rework Trump Administration guidance on the handling of campus sexual assault, providing expanded protections for survivors; and (2) expand Title IX protections against sex/gender-based harassment and discrimination to protect members of the LGBTQ+ community. Expansion of rights to the LGBTQ+ community via Title IX aligns this federal law with current interpretation of Title VII of the Civil Rights Act, which prohibits workplace discrimination on the basis of sex/gender. **AAUW national serves in a gender equity coalition supporting these changes**.

Stay Tuned! It will be a busy summer. We are anticipating needing your help to push back on challenges to this new guidance. The June PP News will include an article that expands on all of this information, and provides updates on impending legal challenges. Thank you in advance!

ARTICLE FOR YOUR JUNE BRANCH NEWSLETTERS AAUW California Advocates for Its Priorities with the Legislature

This year's Lobby Days event, held on April 2nd and 3rd, was exciting and actionpacked. 140 women on 43 teams from 63 AAUW California branches met with 39 Assembly offices and 27 Senate offices. 11 meetings took place in person in Sacramento, 55 meetings took place via Zoom, and the majority took place without a hitch.

While most meetings were conducted with legislative staff, we were able to hold eight meetings with the members themselves - five Assemblymembers and three Senators. We were not able to get a meeting for Zoom Team 7 with Assemblymember Hart, but they did even better when one of their members, Judy Frost from the Santa Maria branch, joined Assemblymember Hart on a hike and lobbied him on the hiking trail.

We were happy to learn that our organization was known to many of the legislative staff and legislators with whom our members met. Some staff had looked up our website prior to meeting and were impressed with programs such as Tech Trek and Gov Trek. Most were supportive of advancing women's equity.

The reception of our "Top 3" bills - AB 2843, AB 2326 and AB 2099 – was generally favorable. The offices were more familiar with the first two, both of which are sponsored by AAUW California. AB 2099 was new to them. You can find more information on these and all the bills we are supporting <u>HERE</u>.

In short, AB 2843 eliminates cost sharing, including deductibles, from being imposed on any rape survivor seeking medical treatment following a rape. Insurers will be required to cover the full cost of medical care. AB 2326 requires the chancellors or presidents from the University of California (UC), the California State University (CSU), and the California Community Colleges, to provide an annual report publicly and orally to the Assembly and Senate Subcommittees on Education Finance on each institution's compliance with Title IX, including sexual assault. AB 2099 would make it possible for the D.A. to file a felony charge for sharing personal information or images of reproductive health care providers or patients, including on the internet, with the intent of causing them harm, if the posting and subsequent action results in bodily injury.

During our Lobby Days event, we were able to get our message across to those who make our laws and to highlight AAUW, our mission, accomplishments and the benefits we bring to our communities throughout California. It was an empowering exercise in advocacy and for those of you who participated, AAUW California thanks you!
